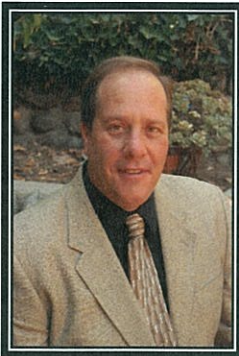

ELECTED OFFICIALS

ELLIOTT ROTHMAN was elected **Mayor of Pomona** in November 2008 and took the oath of office on December 4, 2008. The Mayor serves a four year term which will expire in November of 2012. Prior to being elected to serve as Mayor, Mr. Rothman served as City Council Member for Pomona's District Five from 1996 – 2008 representing the Phillips Ranch, Westmont, and the Cal Poly area.



A Pomona resident for well over 20 years, Mr. Rothman continues to be actively involved in his community. He is a proud supporter and volunteer of a number of local organizations and groups.

One of his noted accomplishments was his initiative to bring the Vietnam Veteran Moving Wall Memorial to the City of Pomona. With five years in the making, the Moving Wall Memorial made its debut in Pomona on Sept. 25, 2003, the only appearance in all of Southern California. In addition, Mr. Rothman was instrumental in the naming of Veteran's Park Soccer Complex in honor of military veterans.

Mayor Rothman is actively serving as a Board Member of the Los Angeles County Sanitation District, and member of the Blue Ribbon Committee of the Los Angeles County Fair Association. He is the City representative on the San Gabriel Valley Mosquito & Vector Control District Board, Four Corners Transportation Coalition, Gold Line Joint Powers Authority, Los Angeles County City Selection Committee, League of California Cities (L.A. County Division), and California Contract Cities Association.

DANIELLE SOTO was elected to the Pomona City Council in November 2008 to represent **District 1**, with her current term continuing through November 2012. Ms. Soto, inspired by her Grandmother former Assemblywoman Nell Soto and Grandfather former Assemblyman Phil Soto, intends to continue her family tradition of open communication with the residents of Pomona, learning their issues and aspirations regarding the community that they call home. Ms. Soto has resided in Pomona for the last 17 years.



Ms. Soto is a graduate from UC Santa Cruz with a degree in Environmental Studies. Ms. Soto's experience includes serving as an intern at the South Coast Air Quality Management District where she currently works as a staff assistant in the legislative and public affairs office. In addition, Ms. Soto has interned as a research assistant for the Coalition for Clean Air. She has a strong interest in transportation, air quality and water quality issues.

Ms. Soto represents the City on the City Council Residential Improvement Task Force, the City – School Liaison Committee, and the Pomona Valley Transportation Authority.

FREDDIE RODRIGUEZ was elected to the Pomona City Council in November of 2006 to represent **District 2**, for a term to expire in November 2010. While serving his constituents, Mr. Rodriguez plans to continue his work towards improving community centers, parks, education and safety for the City's youth and families.

As a lifelong resident of the district, and a graduate of Garey High School, Mr. Rodriguez is deeply rooted in this community and committed to its future. With a 23-year career as an EMT / Paramedic in the San Gabriel Valley, he was honored by the California Ambulance Association with its Star of Life Award in 2006, for his devotion to helping others and his service in the Hurricane Katrina/Rita relief efforts.



Mr. Rodriguez has served education through his efforts as PTA President for Vejar Elementary, the School Site Council for Ranch Hills Elementary, Athletic Director for the Pomona Steelers, and board member of the Southwest Little League. His political interest grew through involvement in his children's athletic activities and his neighborhood watch group.

Mr. Rodriguez represents the City on the City Council Legislative Subcommittee, the City – School Liaison Committee, the Downtown Pomona Owners Association, the Pomona Central Business District, the Pomona-Walnut-Rowland Joint Water Line Commission, the San Gabriel Valley Council of Governments, and the Weed and Seed Committee.

ELECTED OFFICIALS

CRISTINA CARRIZOSA was elected to the Pomona City Council in November of 2006 represent **District 3**, for a term expiring in November 2010. Prior to this election, Mrs. Carrizosa also served on the City Council from 1993 to 2002.



Mrs. Carrizosa is a graduate of California State Polytechnic University Pomona, with both Bachelor's and Master's degrees, and is currently at Philadelphia Elementary as a Resource Teacher. Mrs. Carrizosa is a strong advocate for education and has received numerous recognitions. In 2002, she was

named "Woman of the Year" by Assemblywoman Gloria McLeod (61st District), and in 2005 was recognized as "Teacher of the Year" by State Senator Nell Soto (32nd District).

Mrs. Carrizosa's community involvement mirrors her education efforts, with service including the Philadelphia Bilingual Advisory Committee, Garey High School Advisory Committee, the City – School Liaison Committee, the Pomona Valley Transportation Authority, Tri City Mental Health, and the Weed and Seed Committee.

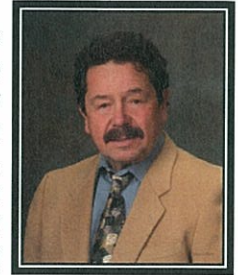
PAULA LANTZ was elected to the Pomona City Council in April 1991 to represent **District 4**, with her current term continuing through November 2012. A life-long resident of Pomona, and a Pomona High School graduate, Ms. Lantz holds a Bachelor of Arts degree in Sociology from Pomona College, and a Masters of Arts degree in Education from Claremont Graduate School.



Ms. Lantz is a credentialed teacher and has taught in Pomona schools. As a registered Social Worker, she worked at Hillview Acres Children's Home in Chino, where she was Foster Care Coordinator, as well as a foster parent for many years.

Ms. Lantz represents the City on the Building Industry Association Government Affairs Committee, the City Council Residential Improvement Task Force, the County Sanitation Districts of LA County, Foothill Transit, the Southern California Associations of Governments, the Pomona Central Business District, the Pomona-Walnut-Rowland Joint Water Line Commission, Tri City Mental Health, and the Vehicle Parking District Ad Hoc Committee.

TIM SAUNDERS was appointed by the City Council to fill the vacant **District 5** City Council seat created when Elliott Rothman became Mayor. Tim's current term runs through November, 2010. Prior to taking office, Tim served as a Planning Commissioner (2003-2008) and Parks and Recreation Commissioner (2002-2003) for District 5. Tim's years of active involvement within the City of Pomona extend beyond the walls of City Hall. Tim volunteers numerous hours of service with the Girl Scouts, the Boy Scouts and various Pomona based soccer organizations. Tim has been a Pomona resident for over 26 years.



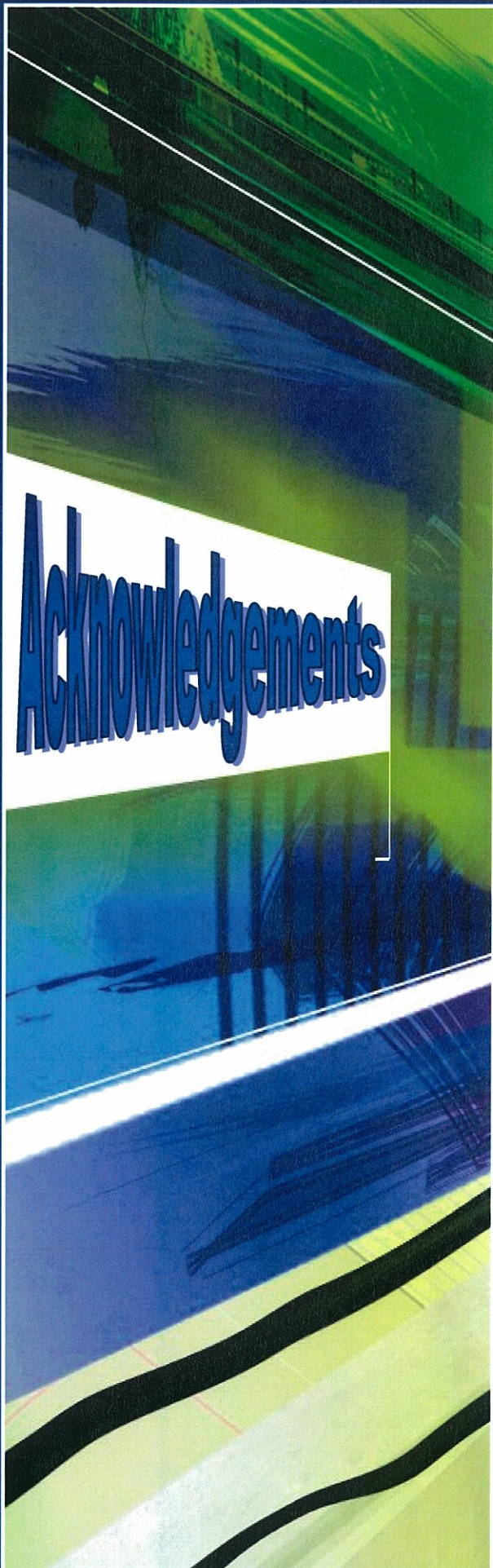
Tim actively serves on the Blue Ribbon Committee of the Los Angeles County Fair Association, is an alternate Council representative to the Pomona Downtown Property Owners Association and is a voting member on the Four Corners Transportation Coalition.

STEPHEN ATCHLEY was elected to the Pomona City Council in November of 2006 to represent **District 6**, for a term to expire in November 2008. He was re-elected to the position in November of 2008 for a term expiring in November 2012. A resident of Pomona since age 11, Mr. Atchley holds a Bachelor's degree in Economics from La Verne College, and a Master's degree – also in Economics – from the University of Southern California (USC).



Mr. Atchley has worked at a variety of jobs over the years having worked in retail sales, construction, network marketing, real estate sales and entertainment. He also taught history and mathematics for the Chaffey, Baldwin Park, and Perris High School Districts. In 2008, he took early retirement from teaching to begin his fifth business in finance and investment development.

Mr. Atchley served on the Planning Commission prior to becoming a City Council member and represents the City on the Blue Ribbon Committee of the LA County Fair Association, City Council Legislative Subcommittee, Gold Line Joint Powers Authority Governing Board, League of California Cities, San Gabriel Valley Council of Governments, and Alameda Corridor East.
