



**CITY OF POMONA POLICE DEPARTMENT, CALIFORNIA
22852 VC – POST STORAGE HEARING REQUEST**

PURPOSE OF A HEARING:

The purpose of a Post Storage Hearing is solely for determining the validity of the impoundment of a vehicle. A hearing is also to determine if a vehicle that is impounded for thirty days is eligible for early release, pursuant to 14602.6 of the California Vehicle Code. As a vehicle owner, you have the right to a Post Storage Hearing Pursuant to 22852 of the California Vehicle Code.

HOW TO REQUEST A HEARING:

The request for a hearing must be within the ten (10) days of the date of mailing of the "Notice of Stored Vehicle." Failure to request a hearing within ten (10) days of the notice, or failure to attend a scheduled hearing will end your right to a hearing. Information regarding this process is available 24 hours a day by calling 909-620-2081.
