PDIT UPDATE

Continuing with IT's goal to modernize computer systems for the Police Department, PDIT have deployed 16 of the 30 new computers recently procured. Additionally, IT strengthened our cybersecurity posture having introduced network traffic encryption at a satellite PD facility as part of our continued commitment to meet or exceed rigorous and new Criminal Justice Information Services (CJIS) compliance requirements. CJIS is a division of the United States Federal Bureau of Investigation and its mission is to provide accurate, timely, and comprehensive criminal information to local agencies but also supports and sets forth information technology guidelines to utilize its systems.

WEBSITE FEEDBACK

IT recently deployed a feedback feature on the City's website to collect information about user experience. We have received some feedback and continue to look forward to receiving valuable information from our visitors to help us improve the usability of our website. GAREY AVE. CLOSED FOR EMERGENCY REPAIRS

Near the intersection of Garey Ave. and Monterey Ave., a small portion of the street has become unstable and has settled slightly due to the recent heavy rains. WATER RESOURCES

CALIFORNIA'S LOW INCOME HOUSEHOLD WATER ASSISTANCE PROGRAM (LIHWAP)

California's Low Income Household Water Assistance Program (LIHWAP) provides critical financial assistance to households struggling to make ends meet. Through LIHWAP, eligible low-income households can receive a one-time financial help to pay current or past due water or sewer bills and keep their water on.

If your household income is below 60% of the state median income for California families – or if you are a recipient of CalFresh, CalWORKs or the Low Income Home Energy Assistance Program (LIHEAP) – you are already income-qualified for LIHWAP.


